Dear Director Orszag:

As members and affiliates of the National Child Abuse Coalition committed to strengthening the federal response to the protection of children and the prevention of child abuse and neglect, we urge your support in the President's Fiscal Year 2011 budget for a significant increase in funding for programs authorized by the Child Abuse Prevention and Treatment Act (CAPTA). For far too many years, the funding for these programs has remained well below the authorized funding levels.

Our request to you for a budget proposal at the authorized funding levels would support innovative practices in child protective services and effective evidence-based and evidence-informed child abuse prevention programs. Additional funding to help states protect children and support families is critical. As the U.S. economy has worsened, increases in reports of child maltreatment have been linked to the weakened state of the economy. The National Research Council has identified unemployment among the stresses associated with child maltreatment in families. Research has shown us that child maltreatment rates are higher in areas with unusually high rates of unemployment. In times of crisis, families need additional supports and services to prevent maltreatment from occurring.

Our nation's child welfare system is stretched far beyond capacity. The Child Welfare League of America has set the standard for CPS caseloads at no more than 12 active investigations per worker per month, yet the average caseload for child welfare workers is nearly double the recommended level, and obviously much higher in many jurisdictions. Federal officials in the Child and Family Service Reviews have repeatedly cited states for such deficiencies as caseworkers who are not visiting children often enough to assess needs; and failure to provide promised medical and mental health services. Increased funding for CAPTA state grants would enable state child protective services to expand post-investigative services for child victims, shorten the time to the delivery of services, support innovative programs that work to address the co-occurrence of child maltreatment and domestic violence, and extend services to other at-risk families.

**Full funding for CAPTA's basic state grants** could be applied to research-based policies and practices such as alternative response and family group decision-making.

- Alternative response offers potential for a major system reform within child protection with a more flexible approach for addressing child maltreatment reports. The alternative response offers an opportunity to engage families and to introduce more prevention services. The results of a randomized control trial on an alternative response approach implemented in Minnesota included the following outcomes: improved child safety,

improved family well-being, reduced recurrence of maltreatment, positive long-term outcomes, and cost savings. A follow-up report concluded that the approach is both cost effective and cost beneficial: system costs declined and the goal of protecting children was achieved.

- Family group decision-making (FGDM) refers to a collection of approaches in which family members come together to make decisions about caring for their children and to develop a plan for services. While approaches differ, they all feature participation by family members (broadly defined) in the assessment and a broad range of decisions to ensure a child's safety. Such family-centered practices have been documented in supporting positive outcomes regarding children's safety, permanency, and well-being. While FGDM is recognized as a successful practice and policy for CPS, the full utilization of these strategies was frequently not evident according to the HHS Child and Family Service Reviews, 2006: "Most states did not excel at engaging families and involving parents and children in the case planning process."

**Full funding for CAPTA's community-based child abuse prevention (CBCAP) grants** would promote more community-wide projects that seek to advance prevention by funding community-based efforts to prevent abuse and neglect. Communities across the country have developed preventive services which show success in programs for new parents, home visitor services, respite and crisis care, parent mutual support-shared leadership and family support services. These community-based organizations play a critical role in delivering prevention services, but their budgets—often based on charitable donations—are likely to suffer during difficult economic times. CBCAP funding could be used to link to other Administration efforts including but not limited to: Promise Neighborhoods, Social Innovation Fund, Early Learning Challenge Fund and other efforts to encourage community collaborations.

We are grateful to the President for giving his priority attention to the protection of vulnerable children and we look to the Administration's continuing support of programs to protect children and to prevent child abuse and neglect. We hope we can count on your leadership to promote these increased funding levels for CAPTA. We greatly appreciate your commitment to ensuring that children at risk of abuse or neglect and their families receive the services necessary to ensure their healthy development.
