This PowerPoint presentation approaches developing a person-centered system from the vantage point of changing the culture of your organization and aiming to create a workplace where person-centered thinking skills are part of every level of work. It challenges the notion that solely providing person-centered planning or being trained in person-centered planning suffices, and provides guidance on what steps to take to go from only implementing person-centered planning in some of your organization's services to becoming a full-fledged person-centered system.

Person-Centered Practices: Leading the Change that Matters Most
