Centers of The Arc, AUCD, UCP and NACDD as well as upon your request. Be prepared to make your Hill appointments as soon as possible.

5. Starting in February, check The Arc, AAIDD, AUCD, UCP and NACDD Web sites for an updated registrant list from your state to prepare yourself for Hill visits.
