Advancing Family-Centered Health Care Services: Opportunities and Challenges

The **Journal of Family Social Work** invites papers for a special issue focusing on implementing family-centered healthcare practices across the lifespan. A family-centered philosophy of care places the individual with a chronic and/or life-threatening health condition in the context of the larger family system and recognizes that the psychosocial well-being of the affected individual is interconnected with that of surrounding family members. The mission of this special issue is to enhance understanding of pathways to support family resilience when living with a chronic and/or life-threatening health condition. Of particular interest are scholarly articles that advance practice knowledge in the following domains:

- psychosocial impact of chronic and/or life-threatening health conditions on family members, including siblings, parents, and spouses/partners
- interventions to support the quality of life of family caregivers of an individual with a chronic and/or life-threatening health condition
- barriers and opportunities to provide family-centered services in diverse healthcare settings

ARTICLE SUBMISSION

Transdisciplinary article submissions are welcome. Articles must be original and follow the APA style (as outlined in the *Publication Manual of the American Psychological Association*). Articles should be a maximum length of 20 typed pages (including abstract and references). All submissions for this special issue must be identified as such in the cover letter. Authors' names, affiliations, and contact information should also be included in the cover letter. Deadline for article receipt is: **May 15, 2008**.
