Data Entry and Data Collection:

- Trainee Surveys are due on June 30th, 2023.
 - The <u>Survey Trainee Reminder</u> offers helpful information to guide you through the process.
 - All other data entry and data cleaning in NIRS for MCHB/OIDD reporting is due July 30th,
 2023.

Reporting for LENDs and DBPs:

- The Autism CARES Module will be open on June 15th, 2023, and should be completed in NIRS by July 27th, 2023.
 - An updated script and demonstration video will be sent when they are available in early June.

Reporting for UCEDDs:

The 2023 Annual UCEDD PPR must be completed and submitted to OIDD by July 30th, 2023.
