# What Does Disability Studies Bring to the AUCD Network?

#### Overview

- The field of disability studies with its interest in cultural meanings of disability, embodied knowledge, political identity, and social justice -- has sometimes been situated in opposition to other disciplines that focus on disability, such as those arising from the medical and applied social sciences, where historically the emphasis has been on curing or fixing disability.
- Within the AUCD network there are a variety of disability studies programs. This poster includes a brief overview of four diverse programs, and another one in development, in regard to their structure, location within the university, and focus.
- Because AUCD leadership and trainee programs typically target emerging and social services fields, the presence of disability studies programs within AUCD affiliated institutions creates an important intersection for engaging diverse perspectives on disability.
- We pose questions about the challenges and possibilities related to the inter- and multi-disciplinary work of disability studies field.
