
2021 Summary of COVID-19 Awareness Projects

The Institute on Disability and Human Development Chicagoland Disabled People of Color Coalition Association of Centers and Universities on Disabilities National COVID-19 Resilience Network Morehouse College School of Medicine In Spring 2021, Chicagoland Disabled People of Color, with support of the Institute on Disability and Human Development (IDHD), partnered the National COVID-19 Resilience Network (NCRN) through a mini-grant where we create events and information on COVID-19 vaccines. resources, and updates to share to the disability community in the Chicagoland area.

We are also connected to a network of organizations throughout the United States who are doing projects on helping marginalized communities through the pandemic.




During the summer of 2021, Chicagoland DPOCC and IDHD put together a social story on updates about COVID-19 vaccinations, including addressing misinformation of the vaccines in communities of color, where to get the vaccine, and updates on which age groups are eligible to receive vaccines.

We will give updates on when the vaccines are available to children under 5 years old and other treatment options for those who are not able to get the vaccine due to certain medical conditions.



We also made a guide that informs the disability community about the delta variant; we will soon create a similar guide that will give important information of the omicron variant of COVID-19 (not the Omarion variant).





While we created the guides, we also partnered with Equip for Equality (an organization that advocates for disability rights in Chicago) and the Sibling Leadership Network to create and share two-page plain language flyers on where people with disabilities can find and ask about getting COVID-19 vaccines at home and mobile sites through the City of Chicago and Cook County suburbs.

When we receive your request we will work to connect you with one of our partners. They will call you to schedule an appointment. Please be patient while we work through a large number of requests. In addition to the guides, we have interviewed a few self-advocates across the state of Illinois; these self-advocates talked about their experiences with getting COVID-19 vaccines and why they chose to get vaccinated.



In October 2021, Chicagoland DPOCC, IDHD, and Interfaith Council hosted a virtual event where people could ask questions or raise concerns to faith leaders in Chicago about how faith and religion can affect one's decision to either get the COVID-19 vaccine or not.



Chicagoland DPOCC has partnered with two organizations, due to our commitment to provide COVID-19 related resources to people of color with disabilities:

Jae Jin and T.J. represents Chicagoland DPOCC and IDHD in Chicago Mayor's Office for People with Disabilities (MOPD) Advisory Committee, where they raise concerns of including people with disabilities in the Chicago economy, conversations on public transportation during the pandemic, and COVID-19 efforts (including health care).

Personal Protective Equipment for People with Disabilities While we have done a lot of great things with creating and supporting COVID-19 related resources in 2021. Chicagoland DPOCC will continue to provide accurate and plain-language information, as well as updated resources and news, related to COVID-19 and disability in the Chicagoland area. For instance, we a currently creating a TikTok channel with interns, where viewers can guickly access latest updates on COVID-19 mandates and information that impact people of color with disabilities.
