**Highlights**

- A. “UCEDD Sexual Health & Disability Efforts Survey”
  - a. 95.5% of UCEDDs completed survey (64 out of 67)
  - b. 64.1% reported working on sexual health topics (41 UCEDDs)
  - c. 98% of UCEDDs were interested in developing capacity in “community education” (n = 50)

- G. UCEDD Sexual Health and Disability Efforts Survey
  - a. Preliminary results were shared during the meeting.
    - o 64 of the 67 UCEDDs completed the survey.
  - b. A formal report will be written and disseminated. The report will include a summary of findings, UCEDDs working on sexual health topics, areas of focus, and contact information for people within the Centers.
- H. Webinar series and IRB for “Sex Talk for Self-Advocates” update
  - a. At the meeting, it was reported we were waiting for IRB approval for survey dissemination; since obtained IRB approval from the University of Wyoming (on 11/15/17).
  - b. The survey asks self-advocates to identify questions they have about relationships and sexuality. These questions will be answered by sexual health educators during the “Sex Talk for Self-Advocates” webinar series.
  - c. \*\*We have received approval and are ready to disseminate the survey. We ask SIG members to disseminate the survey invitation (see the survey invitation file) within your states to listservs and known contacts. We are using a snowball sample so encourage people to share the survey with others.

## **Next Year – 2018**

- A. Webinar series: “Sex Talk for Self-Advocates”

  - b. Recruiting sexuality educators – we have 3-4 educators identified to participate in the webinar as panelists. Let us know if you are interested in joining a panel, we’d love to have a few more.

In addition to the webinar series, journal articles or presentations may be developed to inform the field of disability about the gaps in knowledge related to relationships and sexual health for self-advocates.
