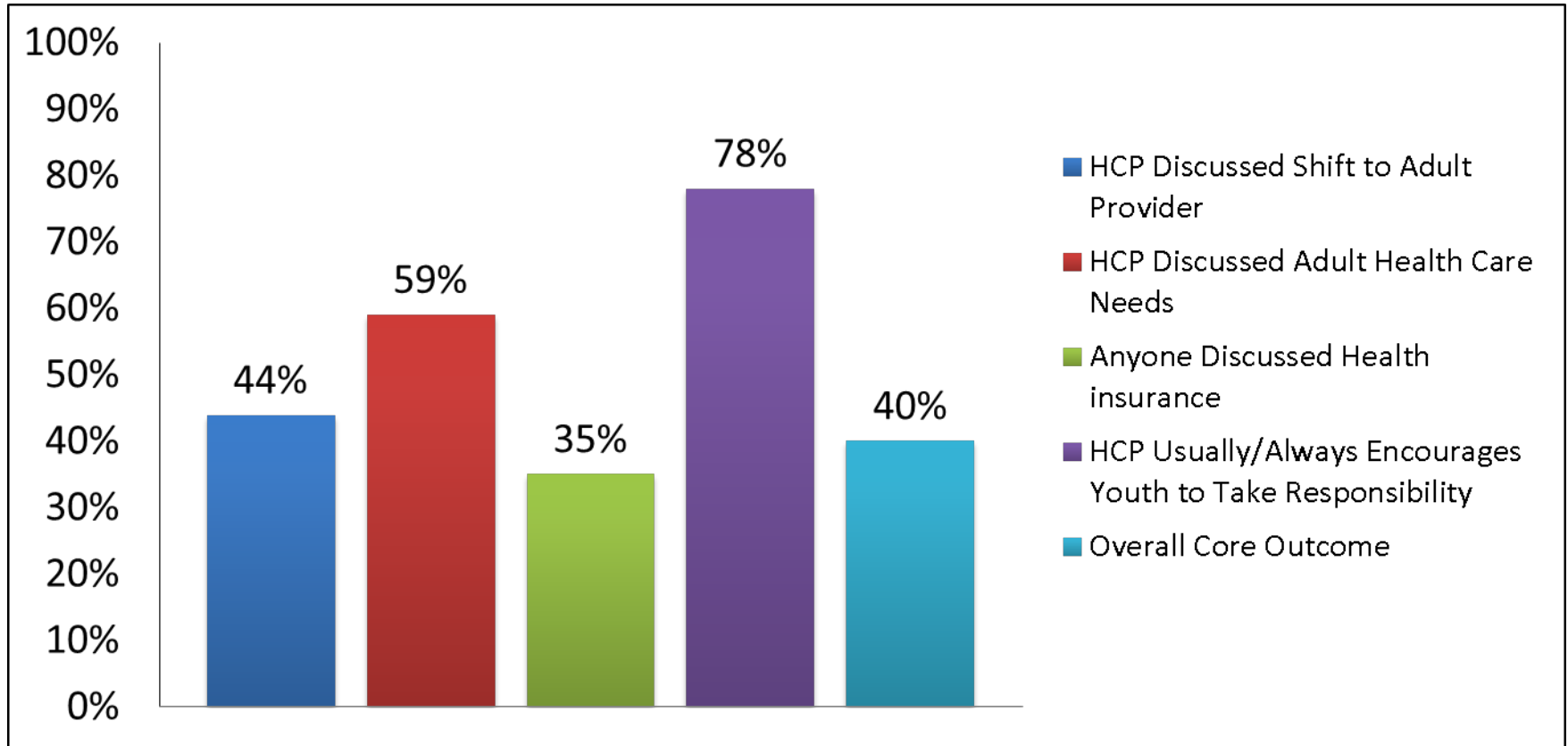

The **ADAPT** Survey- (Modified)

(Assessment of Adolescent Preparation for Transition)



Self-report survey

designed for **adolescents**

16-17 year

with chronic health condition(s)

26 questions

Three composite measures:

1. Patient communication (for patients on no medications)
2. Patient communication (for patients on medications)
3. Caregiver communication (for patients unlikely to progress to independent care as an adult)



Linked to Medical Billing





Increase communication about transition in 14 to 20 year old adolescents/young adults by 10% within 12 months.

Patient Communication

Patient alone for part of the visit	66 (62.3%)	25 (20.5%)	10 (23.8%)
Patient and parent/caregiver together for entire visit	35 (33.0%)	79 (64.7%)	24 (57.1%)
Other	2 (1.9%)	5 (4.1%)	1 (2.4%)
Parent/caregiver alone	2 (1.9%)	0 (0.0%)	0 (0.0%)



Communication about Medication and Health

Talk about the patient being more in charge of his/her health?	69 (66.4%)	85 (69.7%)	35 (83.3%)
Talk about the patient remembering to take his/her medications?	50 (61.7%)	97 (82.9%)	39 (95.1%)
Talk about patient refilling his/her medications?	21 (25.3%)	25 (21.5%)	10 (25.0%)
Talk about need to change to provider who treats adults?	19 (18.8%)	32 (26.2%)	10 (23.8%)
Talk about a specific plan for changing providers?	10 (9.6%)	19 (15.6%)	7 (16.7%)
Give the patient this plan in writing?	1 (0.96%)	1 (0.82%)	0 (0.0%)



Communication with Caregiver about Legal and Health Care Changes with Age

Talk about the patient's health care needs changing?	40 (78.4%)	9 (52.9%)	1 (100%)
Talk about legal issues related to this patient becoming an adult?	34 (66.7%)	4 (25.5%)	0 (0.0%)
Talk about need to change to provider who treats adults?	22 (43.1%)	4 (25.5%)	1 (100%)
Talk about a specific plan for changing?	11 (21.6%)	2 (11.8%)	0 (0.0%)
Give the caregiver this plan in writing?	1 (2.0%)	0 (0.0%)	0 (0.0%)
