



Senate Labor-HHS-Ed Appropriations

September 20, 2019

The Senate Appropriations Committee has posted the FY 2020 Labor-HHS-Education [bill text](#) and [report](#). Please note that this bill did not have a subcommittee or committee hearing and reflects the work of the majority party. You will note that many of the increases provided in the House version are not included in the Senate.

A reminder of process: this bill will need to be voted on by the whole Senate, and then the negotiation process with the House is still in front of us. In short, these should not be viewed as final numbers; instead they are a step.

Reminder of terms: a federal appropriation is the act of setting aside a part of the federal budget to a specific program or use.
