
AUCD Board Governance

- 2014: Added MCC Co-Chair and broadened eligibility criteria for at-large positions beyond Director/Associate
- Significantly increased racial and ethnic diversity of Board nominees and members in 4 years
- 2017: IDDRC directors eligible to vote and run in Board elections; eliminated past-past president
- 2019: Board will ask members for vote on by-laws:
 - Combining Secretary-Treasurer positions
 - o Removing MCC Co-Chair
 - Authorizing Board to create (and phase out, where appropriate) up to 4 additional at-large seats on Board to increase representation for specific constituencies

Financial Year Highlights

- AUCD received a clean audit opinion for the annual and OMB Uniform Guidance audits for the financial year ending on June 30, 2018.
- Year-end unrestricted net assets were \$1,839,660 which is \$18,300 less than the prior year.
- AUCD passed to its members \$2.5 million in funding compared to \$1.2 million of funding in the previous year.
- There have been no dues increases over the past three years.


Multi-Year Unrestricted Net Assets





- Mothers and Babies: Continue to maintain and adapt multi-pronged surveillance approach to rapidly respond to health threats to mothers and babies
- Ready to Learn: Support a healthy launch into school for at-risk children through early screening, identification and intervention for developmental disabilities
- Transition of Care: Implement nationwide transition readiness programs to promote successful transitions from pediatric to adult healthcare for adolescents with disabilities/disorders





Neonatal Abstinence Syndrome NTI

- Purpose: Identify and train practitioners in current and emerging knowledge and evidence-based and promising practices in screening, monitoring and care for children diagnosed with NAS, or suspected of being impacted by opioid use disorder and related trauma exposure
- Activities: Develop & test curriculum and interdisciplinary training model; provide recommendations for future funding to AIDD, CDC, MCHB, SAMHSA
- <u>Awardee</u>: Wyoming Institute for Disabilities partnering with Nisonger Center and UCinn UCEDD

URC Evaluation

- Evaluation designed by Mathematica in 2017 to:
 - Document TA services provided
 - Aid in continuously improving TA
 - Standardize data collection



- First year of data collection completed 2017-2018
- Final report near completion, addressing:
 - TA activities, products, events, collaborations
 - Quality of TA
