



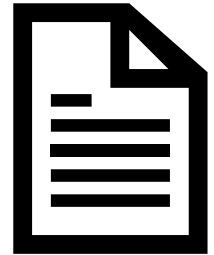

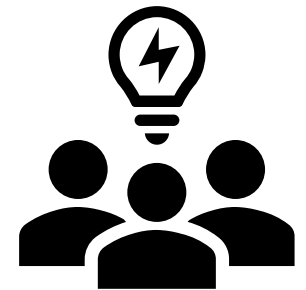
# UCEDD Supplemental Reporting Continued

- When will we know official guidance for CDC supplement? Spring?
- [UCEDD Supplemental Funds Public Comment Request](#)
  - Due November 25<sup>th</sup>, 2022:
    - *“The Administration for Community Living (ACL) is announcing an opportunity for the public to comment on the proposed collection of information listed above. Under the Paperwork Reduction Act of 1995 (PRA), Federal agencies are required to publish a notice in the Federal Register concerning each proposed collection of information, including each proposed extension of an existing collection of information, and to allow 60 days for public comment in response to the notice. This Information Collection (IC) Revision solicits comments on the information collection requirements relating to the National Network of University Centers for Excellence in Developmental Disabilities Education, Research, and Service (UCEDDs) OMB Control Number 0985-0030.”*
  - This will be followed by another 30-day public comment period

# Proposed UCEDD Performance Measure on Equity

- GA CLD UCEDD has been collaborating with OIDD/ACL and AUCD on a potential new reporting measure.
- “Network-wide investments in equity, diversity, and inclusion (EDI) across our institutions seems to have resulted from increased awareness of **health disparities** emerging from the **COVID-19 pandemic**, as well as the social and racial unrest that ensued from cases of police brutality around the nation. These events have highlighted the need for our network to engage in more **culturally responsive** efforts around systems change, capacity building, and advocacy.”







# Proposed UCEDD Performance Measure on Equity Continued

- Seeking Feedback on Proposed UCEDD Performance Measure:
  - “Increasing the % of people with disabilities, including ID/DD, from historically unrepresented communities who participate in the development, implementation, or evaluation of a UCEDD Project”
- Seeking Volunteers from UCEDDs for semi-structured 1-hour interviews
  - Additional input is needed in response to this proposed UCEDD performance measure and efforts to measure the impact of EDI activities in the network
  - Engage more UCEDD Directors and Data Coordinators to better understand the potential implications of the proposed measure

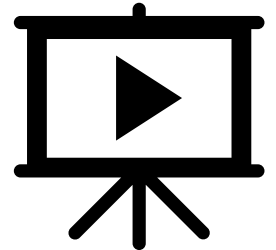
