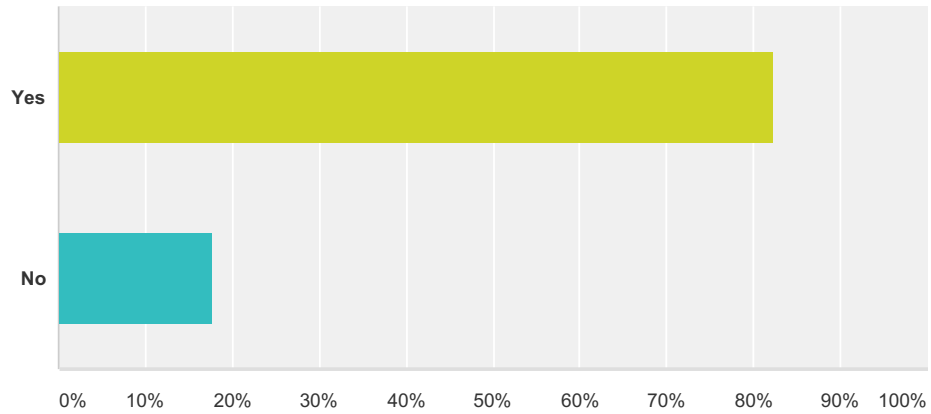


Q1 Does your center have a formal or informal policy for the provision of stipends for self-advocate participation/representation in UCEDD activities?

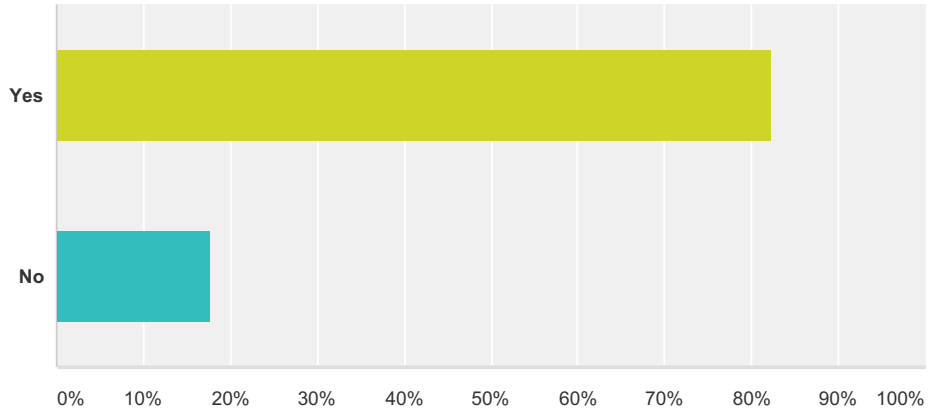

- \$150 per meeting for the CAC. For other activities for family members and self-advocates, it depends on the specific activity but they are always paid for their time.

- Depends, variable gift certificates for some involvement \$20-\$40, research participation can be more depending on the level of involvement

- Self-advocates receive a \$100 stipend for attending CAC meetings.
- CAC Chair - Calls the meetign no less than 4 times in a year, \$75.00 per meeting. CAC members represent individuals with developmental disabilities & related disabilities, family members of individual with developmental disabilities and other related groups.
- The stipend ranges from \$250-\$500 for all of the above.
- CAC (Self Advocates only) - \$50, no others receive a stipend; for others, see question 7.
- \$50
- CAC: None (except travel reimbursement for SA's) SA: varies from project to project. Anywhere from \$20 per hour to \$350 per day - if it's an all day training for example. We cover all travel expenses for SA staff. -Family members: \$150 to cover time and travel for several hours of participation.
- Council Members \$75/meeting Self-Advocates & Family Members - variable based on involvement Range \$200 - 500
- CAC - \$100 Self-Advocates - \$25 to \$50 depends on purpose Family Members - \$25 sometimes depending on purpose
- Consumer Advisory Council Members: \$50 per activity Self-Advocates (not including CAC members): \$50 per activity Family Members (not including CAC members): \$50 per activity

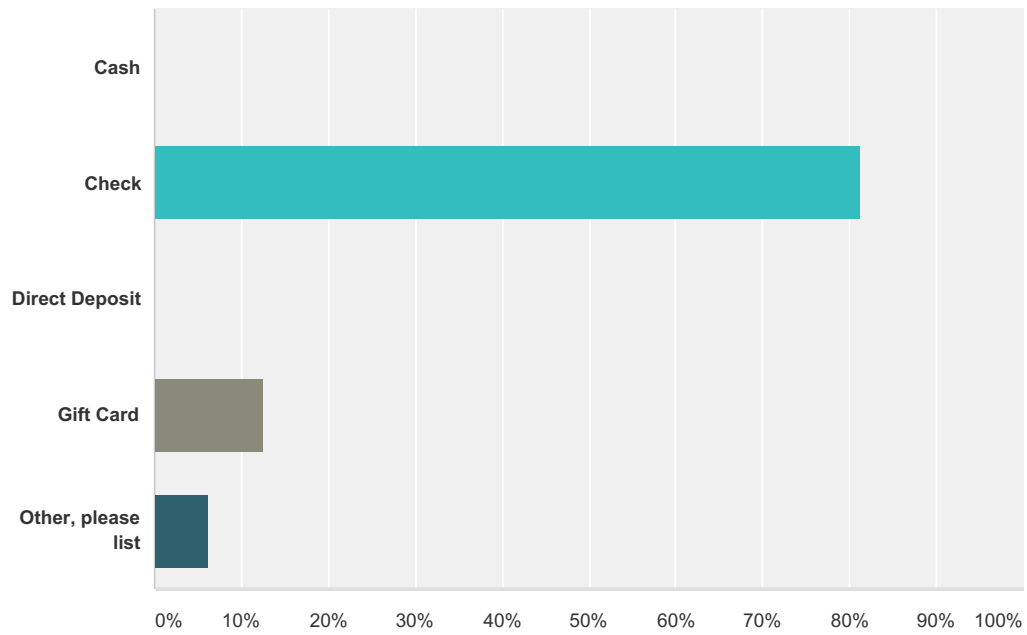

- We provide interpretation services and travel reimbursement. We have never been asked to financially support aides or respite care.

Q6 What barriers exist at your center for payment of stipends or other associated expenses?

- We have an established history of doing this with non-sponsored funds
- They have to be set up as a contract service.
- Bureaucratic obstacles
- None
- Our institution does not understand the difference in daycare and respite care. This has been a battle to reimburse this cost. Gift cards as incentives is another area that is difficult to process.

- Processing paperwork in a timely fashion - i.e. ensuring that people know to fill out the necessary forms ahead of time (e.g. W-9), getting those forms processed, and then waiting for payment to process through the system. We will hear from families if payments don't get turned around quickly. Another barrier is also variance from budget to budget. Some budgets are extremely tight and get spent out quickly, esp. on travel. We are also limited in choice of transportation vendor. Finally, it can be labor intensive to coordinate all the travel needs and trip planning to maximize resources.

- They need to be set up as vendors, with IRS tax information.
- Cost and applicability. For our CAC we are paying transportation for one member (self-advocate) at a cost of over \$600 for taxi to/from 1 CAC meeting per year. She will join by phone for the other meetings.
