

1915 (c) waivers expiring Mar. 17 2014- Mar. 17, 2015

The new regulations regarding settings of Medicaid Home and Community-Based Services took effect March 17, 2014. States have one year to write a transitional plan outlining how they will bring their HCBS systems into compliance with the rules. However, states with waivers up for renewal before March 17, 2015 must submit a transition plan with that waiver renewal application and then have 120 days from the submission of that waiver renewal to submit a transition plan for the remainder of their HCBS system. The regulations apply to 1915(c), 1915(i), and 1915(k) authorities. This list shows the 1915(c) waivers that expire between March 17, 2014 and March 17, 2015. States may have already submitted renewals, especially for waivers in ND, NJ, and OR that expire on 3/31/14 and potentially for those that expire 6/30/14. However, this list is a good starting point for those states that may be writing renewals and transition plans soon.
