Abstract It is expected that by 2030 there will be 171 million individuals living with chronic conditions (RWJF, 2011). Advancements in prevention campaigns, technology, research and medicine have extended the life of individuals but limited attention has been focused on maximizing their quality of life. The current

healthcare model has been tailored to address illness at the acute level and is ill prepared to focus on the long-range life planning. As the population ages we are failing in helping individuals successfully live with chronic needs.

Survivorship, commonly linked to individuals with cancer, is defined as the experience of living with, through and beyond diagnosis as it relates to both the individual and their support system (CDC, LAF). Utilizing a holistic survivorship plan would also help to facilitate and maintain quality of life for individuals living with chronic conditions. Ten key points are identified and range from continued screening to holistically addressing psychosocial issues, health habits and quality of life (IOM, 2005). Collaborative, holistic evidence-based care will be critical if individuals and their supports are to negotiate this journey.

Essential to quality survivorship care is the need for interprofessional collaboration that supports the co-creation of evidence-based plans that take into account one condition, life roles and maximizes quality of life. There is over 50 years of research that documents there are improved health outcomes as well as higher levels of satisfaction and acceptance of care from clients seen through the lens of collaborative practice (IOM, 2010). The presentation will offer concrete ways to utilize existing models as templates for survivorship plans. Application of how this might be actualized for participants will be offered. In addition, discussion regarding the need to broaden the care team to include professionals that are trained in client-centered practice with a holistic perspective (Zenzano, 2011) will also be addressed with hands on practice of collaboration skills.
