


## Focus on the Children's Services Act (CSA)

The Children's Services Act (CSA) was enacted in 199<sup>1</sup>/<sub>5</sub> to provide family-focused and community-based services to at-risk children and their families. Lately, the majority of the CSA budget has been used to pay for private day school tuition. According to a FOIA request made to the Virginia Department of Education (VDOE), the achievement scores (SOL tests) for students enrolled in private day placements is significantly lower than their like-peers in the public school system. This trend has increased significantly over the last 8 years and is creating a system of state-funded segregation.

- The budget allocations for Private Day Placements has increased from \$80M in 2009 to \$157M per year in 2017
- In 2017, tuition for Private Day Placements surpassed all other programs and services as the largest budgetary item for the CSA
