### **Purpose**

## Background Interdisciplinary Training Program in Child Abuse and Neglect (ITP)

- Established in 1987
- Includes: Medicine, Dentistry, Occupational Therapy/Physical Therapy, Psychology, Law, Social Work, Education, Public Health, Nursing, Sociology
- Provides training in clinical practice, prevention, policy formation, child advocacy, research, and administration in the field of child abuse and neglect.

## Oklahoma Leadership Education in Neurodevelopmental and Related Disabilities (OKLEND)

- Established in 1995
- Includes: Audiology, Autism-Spectrum Disorders, Dentistry, Education, Genetic Counseling, Medicine, Nursing, Nutrition, Occupational Therapy, Parent-Family, Physical Therapy, Psychiatry, Psychology, Public Health, Self-advocacy, Social Work and Speech-Language Pathology
- Provides training to enhance the clinical expertise and leadership skills of professionals dedicated to caring for children with neurodevelopmental and other related disabilities.

### The Problem

- Children and youth with disabilities experience a higher rate of maltreatment than children and youth without disabilities.
- Professionals who work with children and families to address child abuse or neglect need information about issues specific to individuals with developmental disabilities that impact the daily lives and function for children and their families.
- Professionals in the field of developmental disability and family and self-advocacy need to learn about the child protective services system and issues related to child maltreatment.

## **Expected Benefits to Participants**

- Deepen knowledge on intersecting issues of developmental disability and child maltreatment.
- ITP participants learn about the unique circumstances of individuals with disabilities, medical, and behavioral issues.
- LEND participants learn about the child protective service system, legal issues and procedures

Consideration of intersecting issues in developmental disability and child abuse and neglect improves services for families
