### Why Does Media Representation of Disability Matter?

- Media can influence how we understand ourselves and others, and how decision makers understand their constituents
- Accurate portrayals of disability are lacking in mainstream media

### Why Does Media Representation of Disability Matter?

- While 20% of the U.S. population has a disability, less than 2% of all television characters are disabled
- 95% of top TV show characters with disabilities are played by non-disabled performers

- How can your connections and followers take action?


