- When surveying former trainees, provide an overview of important terminology, dates, and considerations.
- Supply specific and helpful tools for using NIRS to survey former trainees.
- Provide technical assistance and training to new and existing NIRS users.

## 3.0 Important Timeline for Surveying Former Trainees

- Former trainee surveys should be initiated between January and March to allow sufficient time for trainees to complete the surveys.
- All former trainee surveys must be received/entered in NIRS by June 30th.
- NIRS will remain open for data cleaning throughout July. The only exception is former trainee surveys, which cannot be edited after June 30th.
- If a trainee survey is completed after June 30th, contact [NIRS@aucd.org](mailto:NIRS@aucd.org).

Former trainee surveys are reported as follows:

- **UCEDDs:** Surveys received/entered in NIRS by June 30th will be included in the UCEDD Program Performance Report (PPR) for the current reporting period to OIDD. The PPR is completed in NIRS and uploaded to ACL's Grant Solutions by July 30th each year.

**Reminder:** Be sure to track the number of surveys sent to former trainees regardless of how many surveys are completed, as you are required to enter this information in the PPR.

- **MCHB Training Programs (LENDs/LEAHs/PPCs/DBPs):** Survey responses received/entered in NIRS by June 30th will be included in the data export from NIRS to MCHB's [Discretionary Grants Information System \(DGIS\)](#) for the current reporting period. Survey

## 4.0 OIDD and MCHB Requirements for Former Trainee Surveys

HRSA/MCHB and OIDD/ACL request former trainee surveys annually from trainees who completed your training program 2-, 5-, and 10-years ago.

As a reminder, former trainee surveys may vary based on program type:

Former Trainee Survey Requirements by Federal Funder		
Federal Funder	Trainee Program Type	Survey Requirements
MCHB	LENDs, LEAHs, DBPs	Long-term trainees should be surveyed.
MCHB	PPCs	Long-term and Medium-term trainees should be surveyed separately as survey questions vary.
ACL	UCEDDs	Long-term and/or medium-term trainees should be surveyed.

While your program may survey former trainees at additional intervals, the 2-, 5-, and 10-year surveys are the only surveys shared with OIDD and MCHB.

## 5.0 Helpful Tools for Surveying Former Trainees through NIRS

1) **Standard Reports** in NIRS are predefined reports where the report's content is fixed. Data Coordinators can specify preconditions of data included in the report (e.g., the years of data included, program type, etc.). Standard reports display data previously entered in their respective dataset.

2) **Paper forms** should be used if electronic access to NIRS is unavailable or for accessibility purposes. Paper forms are available in English and Spanish.

## 6.0 Steps to Survey Former Trainees

The following sections provide detailed instructions in the following areas:

- 1) Determine trainees who should be surveyed.
- 2) Locating contact information and their unique survey login.
- 3) Selecting a survey method: Paper or Online forms?
- 4) Managing trainee surveys using paper forms.
- 5) Managing trainee surveys using online forms.

### 6.1 Determine Trainees Who Need to be Surveyed

Former trainees must be surveyed 2-, 5-, and 10-years after graduating from your training program. Use the following standard reports to answer the questions about former trainees:

Standard Reports for Surveying Former Trainee by Trainee Program Type

The reports answer questions such as:

- 1) When did the trainee graduate?

- 2) What type of trainee are they (UCEDD-only, LEND-only, UCEDD + LEND, etc.)?
- 3) Who was enrolled in the training program 2-, 5-, and 10-years ago?
- 4) Were they a long-term (L) or Intermediate/Medium-term trainee (I)?

The following example uses the standard report "Long Term Survey Info (2018+)," located at the bottom of the page under the "LEND, LEAH, PPC, DBP" category.

- 1) Select the current fiscal year, which will generate a table of trainees who were long- and medium-term trainees 2-, 5-, and 10- years ago.
- 2) Carefully note the trainee's **Type** (i.e., Type = "L" = Long-term; Type = "I" = Intermediate) and **Type of Trainee** (i.e., UCEDD, UCEDD/LEND, DBP, etc.) as this will determine which survey link the trainee should be provided.

- 3) In the example above, 'John Doe' has more than one "L" listed under the "Type" column. That means that they were a long-term trainee for two years.
- 4) **Optional step:** if you want to confirm the year that 'John Doe' graduated, navigate to the Trainees dataset > Advanced Search. Data Coordinators should search for them by last name. In the Trainee dataset > Advanced Search, enter the following criteria:

- Fiscal Year = "All Years"

## 6.2 Locating Contact Information and the Unique Survey Login

Once all trainee alumni who need to be surveyed are located, contact them via a preferred contact method. The standard reports list their address, phone, email, and unique survey login.

## 6.3 Selecting a Survey Method: Paper Forms or Online Forms?

There are two methods to collect survey responses from former trainees:

- 1) Paper forms
- 2) Electronic/online form

However, all surveys that are collected must be entered into NIRS. All paper responses must be logged in NIRS by the Data Coordinator. Consider Pros and Cons when using the Paper forms:

## 6.4 Managing Trainee Surveys Using the Paper Forms

Whether paper forms are completed in person by the third party or the trainee alumni, answers should be recorded carefully to allow for accurate data entry.

If paper forms are used, please enter survey responses in NIRS as if you were the trainee. Please follow the instructions listed below to complete the surveys online.

**Reminder:** have a list of unique passwords ready for the trainees who completed a survey on paper form.

- 1) Be sure to select the appropriate survey form based on their trainee type, as survey questions vary. Select the proper survey link based on their trainee program type in the [Survey Instructions](#).

**Reminder:** Required questions are notated with an asterisk (\*) on the paper forms. A former trainee survey cannot be completed without all required responses. Please note that certain questions may allow the option "choose not to disclose."

- 2) To access the survey, select your Center/Program name in the center drop-down, and copy + paste the trainee's unique survey login in the password field. Fill in responses as recorded in the paper forms.

## 6.5 Managing Trainee Surveys Using the Online Forms

If online forms are used, trainees should be sent information on how to complete a survey online.

- 2) **Center Name:** It is important to mention how your Center is listed in the Center Name drop-down menu on the survey page so they can log in. Your center name also is listed at the top of every page in NIRS.
- 3) **Unique Survey Login:** Their unique survey login is in the "Long-Term Survey Information" standard reports or the PPC Medium-Term
