# Section I: Overarching Systems Enhancements

# 1. The NIRS style sheet has been changed.

The "style sheet" refers to the layout, colors, and fonts of the interface. While the layout and fonts remain the same, the new colors of the NIRS interface should be "easier on the eyes" and compliment the colors of the new (as of February 2007) look of the AUCD website.

#### 2. LEAHs and PPCs are welcomed to full NIRS access.

Two MCH training programs, which previously used a limited version of NIRS, have been provided with full access to NIRS.

- Directions in the data entry forms that previously referred to LENDs only have been modified to be directions for "LENDs, LEAHs & PPCs."
- The report pages in each dataset incorporate the LEAHs and PPCs.

# 4. New standard report created to provide count of records added/modified by login name by week.

The report, "Records Added & Edited" is available under "Admin" "Reports." Users can create reports for any desired date range.

#### 5. Disciples have been added or renamed.

The list of disciplines in Trainee and Activity datasets have been updated: Four disciplines have been renamed and seven disciplines added.

#### 6. Definitions provided for Disciplines.

For the first time, definitions are provided for each of the disciplines. The majority of the definitions are adapted from *Classification of Instructional Program: 2000 Edition,* National Center for Education Statistics (2002) (the most recent edition available) and are designed to be consistent with the guidance issued by MCHB. Initial versions of these definitions were reviewed by the Training Directors and Data Coordinators and modified in response to their feedback. See the Appendix of this document for the FY08 NIRS Discipline Definitions.

#### **Section II: Trainee Dataset**

- 7. Trainee discipline list has been modified and discipline definitions provided. See items number 5 and 6.
- **8.** The standard report "Trainees by Discipline and Gender" has been modified. This report now has the same filters as the standard report "Trainees by Race, Ethnicity, and Discipline."
- 9. Trainee "unique identifier" logic has been modified to accommodate cases where former trainees are deceased.

Centers are strongly advised **against deleting** the trainee records of former trainees who have passed away because the value of historical trainee demographic data is not diminished by the demise of former students. NIRS logic has been modified to help Centers take precautions against attempting to survey such individuals in the future.

The unique identifier (trainee login) automatically generated by NIRS for trainees to use to log into their follow up surveys is editable; however, the logic that prevents any Center from having duplicate identifiers has been modified to allow any Center to have an unlimited number of identifiers whose value is the word "deceased."

#### 10. Accessing ST trainee data.

ST Trainee data entry fields are located between "trainee" and "year" fields in the Search and Custom Report functions. ST user defined fields are not automatically included in the main trainee tables during export (to avoid confusion with other trainee user defined fields) but can be exported through the Custom Report function.

#### **Section III: Activities Dataset**

- 11. "In person or live course" option has been added to "Training Method" pull down menu. Within the Performing Training and TA core function, and under its "Training" subset, an additional training method has been provided.
- 12. A blank line has been added to the top of the "Staff Involvement" pull down menu.

It has come to our attention that some individuals entering data have (mistakenly) believed that the first staff person displayed in the pull down menu is automatically linked to the activity record. To reduce the likelihood of such confusion in the future, the first line is now blank. To link one or more staff names to any activity record, a name must be highlighted in the pull down menu, then the button "link this person to the activity" must be clicked.

- **13.** Trainee discipline list has been modified and discipline definitions provided. See items number 5 and 6.
- **14.** The function for creating Product records from the Activity dataset has been discontinued. In response to numerous requests from the network, this feature has been discontinued.

15. Customer satisfaction fields are inactivated when "Research" is selected as a core function.

As consumer satisfaction data are not required by ADD for research and evaluation activities, these fields are inactivated and appear as grayed out in the online data entry form when the "Research" radio dial is selected.

#### 16. Two additional fields have been added to the "Customer Satisfaction" section.

To assist UCEDDs with reporting, two fields have been added that will be incorporated into the FY08 UCEDD annual report to ADD function in NIRS:

- A "yes/no" pulldown menu to indicate if the UCEDD was the "lead" on the activity. Guidance from ADD indicates that Centers are not obligated to attempt to collect satisfaction data in activities that they do not lead (e.g., speaking at a conference you do not host).
- A text box to indicate the number of customers surveyed. This figure will be used to autocalculate response rate in the annual report.

#### **Section IV: Projects Dataset**

17. New standard report created to provide, for each project, a list of associated activities, the number of participants, and duration.

The report "Projects and Associated Activity Records" is available on the Projects reports page under "All."

#### **Section V: Products Dataset**

18. The authority to add/modify product dissemination numbers has been restricted.

In response from numerous requests from the network, this feature has been restricted to the owner of the Product record itself and users with an Admin level of access.

19. The capacity to add a URL to the abstract (presumably to the product itself) is enabled.

URLs can be provided with or without the <a href="http://">http://</a> prefix; no special tagging or formatting is needed. Once saved, the URL will display in "view" mode and in the public search as an underlined link. The clicked link will open in a new window.

NOTE: Users are cautioned to use this function when they are sure that the link will be remain valid for some time.

## Section VI: Public Search of NIRS

20. A prominent link for searching NIRS has been added to the AUCD homepage. NIRS Login> National Information Reporting System Search NIRS for Network Projects and Activities Search>

21. The default search option has been changed from "current year" to most recent "complete data year."

Users will continue to be able to change their search criteria by particular or "all" years.

22. The first pulldown menu line for "Center Name" has been changed.

While the function of searching all UCEDDs and LENDs remains unchanged, the line has been changed from blank to "Search all UCEDDs/LENDs."

23. "All years" search results are now filtered to display only the most recent FY of a project. When the same project title is used by a Center over multiple years, only the most recent record will be returned in the search; however, the record now provides links to all previous Product year records.

## **Section VII: Directory**

#### 24. The discipline list has been revised.

Continue to check all that apply.

#### 25. Check boxes are provided to indicate an individual's membership on an AUCD council.

Council membership will not be displayed in an individual's directory listing (however a list of Council members can be obtained through the search function, see item number 26). Eventually, we hope to be able to generate lists of Council members for access through the council web pages from the directory, streamlining the updating activities. Check all that apply.

# 26. An additional check box is provided to filter non-staff COCA representatives out of Directory display.

For those COCA representatives who are not employees of a UCEDD—and therefore should not display in the UCEDD's directory—we have provided a mechanism for Centers to manage their online listing of their COCA representative without displaying the individual in their online staff list.

**NOTE**: DO NOT enter any information in Sections II or III of the directory record for non-staff COCA representatives. These Sections are to be used solely for <u>employees</u>.

# 27. AUCD Council names have been added to the bottom of the list of "positions" in the directory search.

Select the appropriate Council to generate a list of membership from Directory entries.

#### 28. The capacity to add a URL to the vita section is enabled.

URLs can be provided with or without the <a href="http://">http://</a> prefix; no special tagging or formatting is needed. Once saved, the URL will display in "view" mode and in the public search as an underlined link. The clicked link will open in a new window.

NOTE: Users are cautioned to use this function when they are sure that the link will be remain valid for some time.

#### 29. Report created to display Directory entries.

The report "Staff Expertise" displays, by staff name: discipline(s) and text entered in their "Research," "Education," and "Service" fields.
