IMPORTANT TIMELINE

It a good time of year to begin surveying former trainees in the January – March timeframe to allow plenty of time to receive the surveys from your trainees and to boost survey responses. Please read carefully below, as this message contains important details and guidelines to help you through this process.

Please note that we are in FY2023/PY2022, meaning that all new records entered into NIRS for the current reporting period should be for the time frame between July 1st, 2022, and June 30th, 2023. As such, all former trainee **surveys must be received/entered in NIRS by June 30, 2023.** If a trainee survey is completed after June 30th, please message nirs@aucd.org.

Even though NIRS will remain open for programs to clean their data until August 1st, 2023, any surveys received/entered **after** June 30, 2023, **WILL NOT** be included in the reporting for FY2023/PY2022. Trainee surveys are reported as follows:

 UCEDDs: Surveys received/entered in NIRS by June 30, 2023, will be included in the FY 2023 UCEDD Program Performance Report (PPR) to OIDD, which is due July 30th and is completed in NIRS.

Reminder: Be sure track the number of surveys you send out regardless of how many surveys are completed, as you will be required to enter this information in the PPR.

 MCHB Training Programs (LENDs/LEAHs/PPCs/DBPs): Survey responses received/entered in NIRS by June 30, 2023 will be included in the FY2023/PY2022 data export from NIRS to <u>DGIS/EHB</u>; survey data will populate in the Former Trainee Information form in the EHB.

WHO TO SURVEY FOR OIDD AND MCHB REPORTING

The trainees you will be surveying this year for **OIDD** and **MCHB** reporting are former **long-term** trainees who completed your training program **2-**, **5-**, **and 10-years ago**. This will include former trainees from **FY2021/PY2020**, **FY2018/PY2017**, and/or **FY2013/PY2012**

While your program may survey former trainees at additional intervals, the 2-, 5-, and 10-year surveys are the only surveys shared with OIDD and MCHB.







RESOURCES

Standard Reports: Please note that admin-level access is required to view the standard reports described below.

- For UCEDDs: A standard report in the Trainee dataset will be very useful with surveying your UCEDD-only and/or UCEDD/LEND trainees. It is located in the Trainee dataset > Standard Reports > Long Term Survey Info 2020+" under the UCEDD category. The "Long Term Survey Info 2020+" standard report under the UCEDD category will assist with surveying your UCEDD-only and/or UCEDD/LEND trainees.
- For MCHB Training Programs: There is another standard report that will be useful with surveying LEND-only and/or LEND/UCEDD trainees. It is located in the Trainee dataset > Standard Reports > "Long Term Survey Info (2018+)" at the bottom of the page under the LEND, LEAH, PPC, DBP category. The report will assist with surveying your LEND-only and/or UCEDD/LEND trainees.
- PPC Programs: A separate report is available to help track the completion of Medium-Term Trainee Surveys. The report is located in the Trainee dataset > Standard Reports > "PPC Medium Term Trainee Survey Info" under the LEND, LEAH, PPC, DBP category. This report provides information for the Medium-Term Trainee surveys.

Please note that data entry into NIRS should be in English.

If you use paper forms, when you receive a paper survey completed, you will have to enter it in NIRS just as if you were the trainee. You can follow the instructions listed below for completing the surveys online.







USING THE STANDARD REPORTS

Upon selecting the fiscal year (2023), the standard report will generate a table of trainees to be surveyed in the selected fiscal year: **FY2021/PY2020** (2-years ago), **FY2018/PY2017** (5-years ago), and **FY2013/PY2012** (10-years ago).

As previously mentioned, **MCHB** and **OIDD** are only interested in former long-term trainee surveys. Please pay special attention to the trainee's **Type** (i.e., Type=" L" = Long-term; Type=" I" = Intermediate). and **Type of trainee** (i.e., UCEDD, UCEDD/LEND, DBP, etc.) as this will determine which survey link the trainee should be provided.

When communicating with trainees about the trainee survey, please include the following information:
